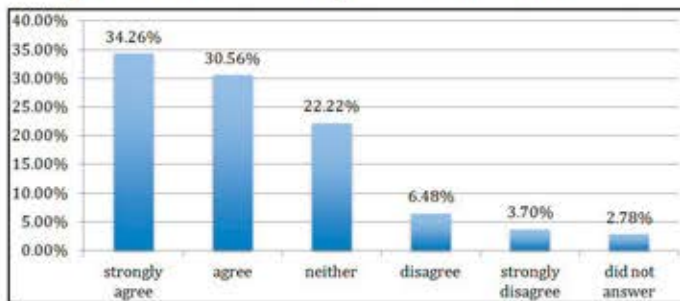
NWNA Cut Through Traffic Neighborhood Assessment Survey Report by Helen Chin—NWNA Traffic Liaison

Thank you for participating in the NWNA Cut Through Traffic Neighborhood Assessment Survey. Your input and experiences are invaluable to building our case to address the high speed and reckless cut through traffic in our neighborhood. We received about 100 completed surveys over the last two months. In addition to the data that you submitted, we also received countless stories and anecdotes that further illustrate the traffic problems we're experiencing. We plan to make the data available to the city agencies and to Councilman Mike Bonin's office. From the survey data, we learned that 58% of the residents in North Westdale are youth and older adults; 91% own their homes while 8% are apartment dwellers.

Here is where things get interesting...

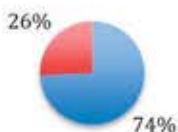
Over 60% of people agree or strongly agree that they would use their front yards, ride bikes, walk, or use their outdoor spaces more if they felt safer.

A mind-boggling 74% of residents have experienced close calls! And 15% have experienced an accident from the high speed traffic. Let's do something so this number does not go up.

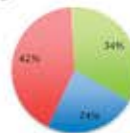
Have you personally experienced or know of someone who experienced close calls while being out in your own neighborhood?

Age Breakdown

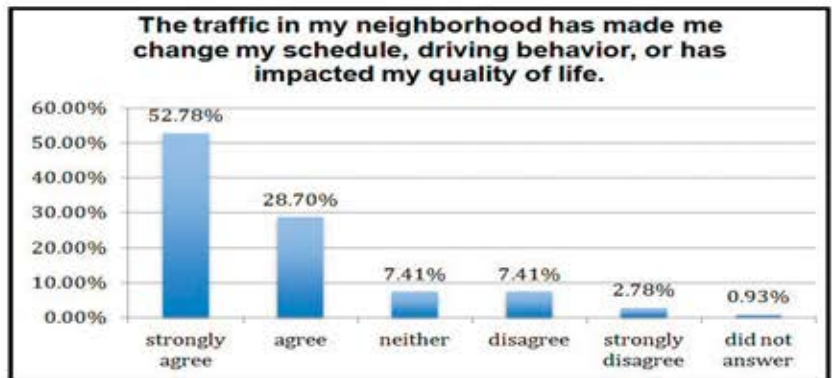


■ 0-30 years ■ 31-60 years ■ 61-100+ years

Over 80% of residents responded that the traffic has impacted their quality of life. They have had to alter their schedules or driving behavior due to the traffic backed up on their streets, cars using their driveways to make 3-point turns, or cars speeding during rush hour.

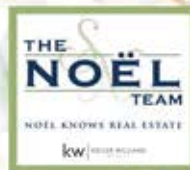
